TOP FIVE REASONS TO GET BLACKWATER OFF OUR BORDER AND OUT OF SAN DIEGO

1. Blackwater, a mercenary group, has a history of killing innocent civilians. On September 16, 2007, Blackwater "security personnel" shot and killed without provocation seventeen Iraqi civilians, including a nine year old boy in Nisour Square.
2. Blackwater claims no responsibility for the killings. One month after the Nisour Square massacre, Blackwater founder, Erik Prince, had the nerve to tell Congress he had no knowledge of his men hurting innocent civilians.
3. Blackwater is not part of the military! It is a private company profiting from bloodshed and killing. Blackwater personnel are immune to military or civil criminal law. Thus far, no one at Blackwater has been charged for any of the Nisour Square killings.
4. Blackwater used "shadow" business names to apply for the Otay Mesa building permit avoiding public recognition by San Diego residents and city administrators. Blackwater circumvented the City Council, the City Attorney, and San Diego residents by suing the City and going to a Federal judge appointed by George H.W. Bush to get their building permit.
5. Blackwater profits from conflict. **NO CONFLICT = NO PROFIT!** Why would they choose to be near the border? Because they can easily exploit any minor differences among ethnic groups along the border so they can intervene and continue to rake in even more money.
